**RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release") is made effective as of November 20, 2017, by GRAYCLIFF MEZZANINE II, LP, a Delaware limited partnership (the "Secured Party") in favor of DWELLWORKS, LLC, a Delaware limited liability company (the "Company"), and the other Persons party to this Release (collectively with the Company, "Debtor").

WHEREAS, Debtor and the other borrowers from time to time party thereto (collectively with Debtor, the "Borrowers"), Secured Party, and the lenders from time to time party thereto (collectively, the "Lenders") entered into that certain Loan Agreement dated as of December 23, 2014 (as amended, restated, or supplemented from time to time, the "Loan Agreement");

WHEREAS, the Debtor has granted security interests to the Secured Party under the Patent and Trademark Security Agreement dated as of December 23, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Debtor granted the Secured Party, among other collateral as set forth therein, a security interest in and lien on the trademarks and patents identified on Exhibit A hereto (the "IP Collateral");

WHEREAS, the granting of the security interest in the IP Collateral was recorded with the United States Patent and Trademark Office against the IP Collateral on January 2, 2015 at Reel number 5433 and Frame number 0738, and at Reel number 034613 and Frame number 0522; and

WHEREAS, the Debtor has satisfied all of the obligations under the Loan Agreement and the Security Agreement and has requested that the Secured Party terminate and release its security interests in and liens on the IP Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Loan Agreement or the Security Agreement, as the case may be.

2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the IP Collateral, including, without limitation, the trademarks and patents listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Debtor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such trademarks and patents, effective as of the date set forth above.


