**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of November 21, 2017, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a United States national banking association (the “Collateral Agent”) in favor of **CIPHER SYSTEMS, LLC**, a Maryland limited liability company with an address at 2661 Riva Road, Building 1000, 5th Floor, Annapolis, Maryland 21401 (the “Pledgor”).

W I T N E S S E T H:

WHEREAS, Pledgor entered into a certain trademark security agreement dated February 13, 2015 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on February 19, 2015 at the United States Patent and Trademark Office at Reel 5462, Frame 0791.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its Trademark Collateral, including the Trademarks listed in Schedule 1, and all goodwill associated with such Trademarks.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgor, including all goodwill associated with the Trademark Collateral, and assigns, transfers and conveys to Pledgor any interest in such intellectual property, including the Security Interest. The Collateral Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Pledgor and its successors and assigns in association with the Security Interest, and hereby releases the Pledgor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
