TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of November 21, 2017, by and between WEBSTER BUSINESS CREDIT CORPORATION, a New York Corporation with an office at 360 Lexington Avenue, New York, New York 10017, (the "Lender"), and ACI, Inc., a New Jersey corporation having its principal place of business at 950 Third Avenue, New York, New York 10022 (the "Company").

WHEREAS, pursuant to the terms of (1) the Credit and Security Agreement dated May 30, 2013 between the Company and the Lender and (2) the Trademark Security Agreement dated as of May 30, 2013 between the Company and the Lender and recorded with the U.S. Patent and Trademark Office on June 14, 2013 at Trademark Reel 005047 and Frame 0218, the Company granted to Lender a security interest in and lien on, and collaterally assigned to the Lender certain trademarks, trademark registrations, associated goodwill and all products and proceeds of the foregoing, including without limitation, the trademarks referred to in Schedule I attached hereto (such trademarks referred to herein as the "Named Trademarks"); and

WHEREAS, the lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender and the Company hereby agree as follows:

1. **Release and Assignment.** The Lender hereby, without any representation and warrant and without any recourse to Lender, terminates and releases its security interest in and first priority lien on all of the Company's Named Trademarks, and the Lender hereby assigns and transfers to the Company, without any representation and warrant and without recourse, all of the Lender's right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.
2. **Acknowledgement and Acceptance.** The Company hereby acknowledges and accepts the foregoing release and assignment by the Lender.
3. **Counterparts.** This Release may be executed in any number of counterparts which together constitute one and the same agreement.

IN WITNESS WHEREOF, the Lender and the Company have executed this Release, to take effect as of the date first set forth above.
