**MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

Under the terms of that certain Fourth Amended and Restated Credit Agreement dated as of June 11, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and that certain Amended and Restated Security Agreement dated as of April 2, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") entered into between the Grantors and Wells Fargo Capital Finance, LLC, a Delaware limited liability company ("Agent"), Grantors granted to Agent, for the ratable benefit of Agent and the Lenders, a security interest in the trademarks and trademark registrations and applications therefor which are identified on Schedule A attached hereto and incorporated herein by this reference (the "Trademarks"), together with the goodwill thereto owned by Grantors, which Trademarks are appurtenant, and all actions for infringement concerning the foregoing.

Capitalized terms used but not defined herein shall have the meanings given them in the Credit Agreement.
