FIRST: That on July 28, 2017, the Board of Directors of the Corporation unanimously consented to a proposed amendment of the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling for approval thereof by the sole stockholder of the Corporation. The consent set forth that the Certificate of Incorporation of the Corporation be amended by deleting and replacing Article FIRST of the Certificate of Incorporation in its entirety so that, as amended, Article FIRST shall be and read as follows:

FIRST: The name of the Corporation is Windstream BV Holdings, Inc. (the "Corporation").

SECOND: That all other articles, sections and subsections of the Certificate of Incorporation of the Corporation shall remain unchanged.


THIRD: That the sole stockholder of the Corporation's capital stock, unanimously approved said amendment.
