**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 21, 2017 (the “Effective Date”), is made by CITIBANK, N.A., in its capacity as collateral agent (the “Agent”), in favor of VWR INTERNATIONAL, LLC (“VWR”), BIOEXPRESS, LLC (“Bioexpress”), AMRESKO, LLC (“Amresco”), TEK PRODUCTS, INC. (“TEK”), INTEGRA COMPANIES, LLC (“Integra”) (VWR, Bioexpress, Amresco, TEK, and Integra, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of September 28, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of September 28, 2015 (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;


WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 29, 2015 at Reel/Frame 5632/0460.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Guarantee and Collateral Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to all of each Grantor’s right, title and interest in or to the Trademark Collateral, including the trademarks and trademark applications set forth on Schedule I attached hereto, arising under the Guarantee and Collateral Agreement and the Trademark Security Agreement, and any and all right, title and interest of the Agent in and to the Trademark Collateral shall hereby terminate, cease and become void.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
