NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of November 13, 2017 is made by Wells Fargo Bank, National Association (as successor to Wachovia Bank, National Association), in its capacity as Bank (referred to herein as the "Bank"), in favor of TaylorMade Golf Company, Inc. (as successor in interest to Adams Golf IP, L.P., Adams Golf, Ltd. and WGU, LLC), a Delaware corporation (the "Company"), pursuant to that certain Loan and Security Agreement, dated as of November 13, 2007 (and as the same may be further amended or modified from time to time, the "Security Agreement"), among the Company, the Bank and other parties thereto.

W I T N E S S E T H:

WHEREAS, in connection with the Security Agreement, the Company executed and delivered the following agreements in favor of the Bank (the "Trademark Security Agreements"): (i) Security Interests in United States Trademarks (Adams Golf, Ltd.), dated as of November 13, 2007; (ii) Security Interests in United States Trademarks (Adams Golf IP, L.P.), dated as of November 13, 2007 and (iii) Security Interests in United States Trademarks (WGU, LLC), dated as of November 13, 2007;

WHEREAS, pursuant to the Trademark Security Agreements, the Company granted the Bank a security interest in all of the Company's right, title and interest in and to the trademarks and trademark applications set forth on Schedule A attached hereto, together with the goodwill of the business symbolized thereby (the "Released Trademarks");

WHEREAS, the Bank recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the "USPTO") on December 6, 2007, at (i) Reel/Frame No. 3673/0754, (ii) Reel/Frame No. 3673/0734 and (iii) Reel/Frame No. 3673/0761; and

WHEREAS, the Bank has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreements (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreements).

SECTION 2. Release of Security Interest. The Bank does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Bank hereby terminates and cancels the Trademark Security Agreements.

SECTION 4. Further Assurances. The Bank hereby authorizes the Company or the Company's authorized representative to (i) record this Release with the USPTO, and /or (ii) otherwise record or file this Release in the applicable governmental office or agency. The Bank further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or their agents or designees) reasonably request (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.


SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
