TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment") is entered into *nunc pro tunc* as of January 2, 2017, by and between Unisa America, Inc., a Delaware corporation ("Assignor") and Unisa Fisher LLC, a Delaware limited liability company ("Assignee").

WHEREAS:

- A. Assignor and Assignee are parties to that certain American License Agreement (the "License Agreement") and Option Agreement to Purchase Trademarks Licensed Under the American License Agreement (the "Option Agreement") both dated as of March 21, 2007 and both subsequently amended as of October 31, 2008; July 17, 2009; February 26, 2015; and December 31, 2015.
- B. Pursuant to the Option Agreement, Assignee has the option ("Option") to acquire the entire right, title, interest, and goodwill in and to the Trademarks (as defined hereunder).
- C. Assignee has exercised the Option.
- D. In order to effectuate Assignor's assignment to Assignee of its entire rights, title and interests in and to the Trademarks pursuant to the Option, Assignor and Assignee are executing this instrument of assignment.

NOW THEREFORE, for the consideration set forth herein, as well as for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby further agree as follows:

1. Definitions.

- (a) "Territory" means the United States (its possessions and territories, including Puerto Rico), Canada, and all countries in Central American north of the southern border of Panama, and the Caribbean (excluding Cuba, Guadalupe, French Guiana, Martinique, and Netherland Antilles consisting of Aruba, Bonaire, Curaçao, Saba, Sint Eustatius and the southern part of the island of Saint Martin, known as Sint Maarten).
- (b) "Trademarks" means the trademarks/service marks identified on attached Exhibit A, as well as any rights Assignor has to use any trademarks that contain the element "UNISA," solely within the Territory.

2. Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire right, title and interest in and to, including, without limitation, any and all common law rights thereto, as well as the goodwill of the business symbolized by, the Trademarks.

3. Assignor hereby covenants and warrants that, with respect to each Trademark, it has the full right to convey the above-described right, title, interest and goodwill by this instrument, free of any encumbrances. Assignor further covenants and warrants that no other agreement has been or will be executed in conflict herewith.


4. Assignor agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described transfer of rights, or to secure registration before the United States Patent and Trademark Office or any foreign Office, at Assignee's expense.
5. Assignor further authorizes the Commissioner of Patents and Trademarks of the United States and the appropriate official in any other country, to issue any and all trademark registrations, amended registrations and/or renewals that may be granted upon any application or petition for same, to Assignee, and/or Assignee's successors and/or assigns.
6. Assignor hereby grants to the designated attorneys of Assignee, the authority and power to insert on this instrument, any further identification which may be necessary or desirable for purposes of recordation by the United States Patent and Trademark Office or the Trademark Office of any other country throughout the world.
7. Upon execution of this Assignment, Assignee shall pay to Assignor the sum of \$1.00.
