## Trademark Assignment Agreement LINKERD

This Trademark Assignment Agreement (“Agreement”) is effective as of the 18 th day of November, 2017 by and between The Linux Foundation, an Oregon non-profit corporation (“Assignee”), having a place of business at 1 Letterman Drive, Building D, Suite D4700, San Francisco California, 94129, USA, and Buoyant, Inc., a Delaware corporation (“Assignor”), having a place of business at 577 Howard Street; 4th Floor, San Francisco, California, 94105, USA.

- 1) **Background.** Assignor is the owner of the LINKERD trademark, domain names and other source indicators and all registered accounts that either (i) incorporate “linkerd” or (ii) are used, or relied upon, by the project (including, without limitation, social media and GitHub accounts (“Accounts”)), including without limitation the applications and registrations therefor and the common law trademarks set forth in Schedule 1 (collectively, the “Trademarks”). Assignor wishes to assign the rights to the Trademarks to Assignee.
- 2) **Assignment of Rights.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee, its successors and assigns, in perpetuity all rights, title and interest as Assignor may possess, anywhere in the world, in and to the Trademarks together with the goodwill symbolized by said Trademarks.
- 3) **Assistance.** Assignor will assist Assignee as reasonably necessary to transfer, secure, perfect, maintain or evidence the rights hereby assigned. Assignor will take such reasonable action as may be required to transfer any domain name and ownership for any Account to The Linux Foundation, as The Linux Foundation may reasonably request. To the best knowledge of Assignor, neither the execution or performance of this Agreement will violate the terms of any agreement between the Assignor and any third party.

To the best knowledge of Assignor, the list of trademark and other source indicators on Schedule 1 is a complete list of items containing the term “linkerd” and neither the execution or performance of this Agreement will violate the terms of any agreement between the Assignor and any third party. Assignor agrees not to use the Trademarks after the effective date of the assignment except as expressly permitted by Assignee, and will not challenge, interfere with or oppose Assignee’s use, application or registration of the Trademarks.

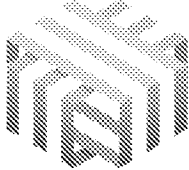
