TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into as of [11/7], 2017 ("Effective Date") by and between **Thomas Sinton** ("Assignor"), and **Starfield Vineyards, LLC** ("Assignee"), each of Assignor and Assignee a "Party", and collectively, the "Parties").

WHEREAS, Assignor wishes to hereby assign to Assignee, and Assignee wishes to acquire from Assignor, any and all right, title and interest that Assignor owns in the trademarks and applications to register trademarks listed on **Schedule A** attached hereto (trademarks collectively the "**Marks**" and applications collectively the "**Applications**"), and all common-law rights associated therewith and all goodwill of the business associated therewith and symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably and unconditionally assigns to Assignee, all of Assignor's worldwide right, title, and interest in and to the Marks and Applications, together with the goodwill of the business symbolized by the Marks and Applications, as successor of the business to which the Marks and Applications relate. Assignor further irrevocably and unconditionally assigns to Assignee the right to bring all claims in Assignee's own name for past, present, and future infringement, misappropriation, or other violation of the Marks and marks issuing from the Applications, on a world-wide basis, including all rights to sue for and to receive and recover all profits and damages accruing from an infringement, misappropriation, dilution, or other injury or violation as well as the right to grant releases for past, present and future infringements, dilution, or other injury to the goodwill thereof. The Applications are being assigned as part of the entire business or portion thereof to which the trademarks and service marks pertain, as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060.

2. Assignor hereby requests the United States Patent and Trademark Office, and any corresponding entities or agencies in any applicable foreign jurisdictions, to record Assignee as the assignee and owner of the Marks and Applications.

3. Assignor hereby agrees to execute all such documents as may be required to transfer and, when applicable, to record the transfer of the Marks and Applications, any registrations for the Marks, and any trademarks issuing from Applications.


