RESOLVED, that the first Article of the Certificate of Incorporation of the Corporation be amended to read as follows:

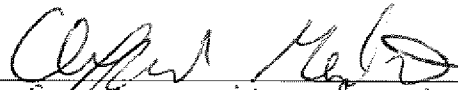
FIRST. The name of the corporation is KYOCERA SENCO Brands, Inc. (the "Corporation").
