**SUPPLEMENTAL TERMINATION AND RELEASE OF
SECURITY INTERESTS IN TRADEMARKS**

This Supplemental Termination and Release (the "Termination and Release") is granted as of November ____, 2017, from Citicorp USA, Inc. as collateral agent (the "Collateral Agent") for the banks and other financial institutions that are parties to the Credit Agreement dated August 1, 2006, to Davis Vision, Inc.; Davisvision IPA, Inc.; Davis Vision of Nevada Inc.; DVSC, Inc.; Empire Vision Center, Inc.; Viva Optique, Inc.; Viva Europa, Inc.; Viva International, Inc.; Viva IP Corp.; and Miracle Optics (hereinafter collectively referred to as the "Pledgors").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement dated August 1, 2006 (the "Trademark Security Agreement"), made by the Pledgors in favor of Collateral Agent, security interests (the "Security Interests") were granted to the Collateral Agent in the trademark registrations set forth in attached Schedule A (the "Visionworks Trademarks"); and

WHEREAS, the Pledgors have advised the Collateral Agent that (a) the Visionworks Trademarks set forth on Schedule A were erroneously included in the Trademark Security Agreement, and (b) the Visionworks Trademarks were owned, as of the date of the Trademark Security Agreement by ECCA Enterprises, Inc., which has since changed its name to Visionworks Enterprises, Inc.;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on September 7, 2006, at Reel 3385, Frame 0034; and

WHEREAS, the Pledgors have requested that the Collateral Agent supplement the Termination and Release of Security Interests in Trademarks it previously executed on November 27, 2013, which instrument was recorded in the United States Patent and Trademark Office on July 22, 2016, at Reel 5837, Frame 0450 (the "Prior Termination") with this Termination and Release.

NOW THEREFORE, in order to supplement the Prior Termination, the Collateral Agent hereby agrees as follows:

1. Release. The Collateral Agent hereby terminates releases and discharges any Security Interests it may have obtained in the Visionworks Trademarks under the Trademark Security Agreement, and any right, title or interest of the Collateral Agent in such Visionworks Trademarks shall hereby immediately cease and be discharged.

2. Authorization to USPTO: The Collateral Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office to release the above-referenced Security Interests in the Visionworks Trademarks.

3. Further Assurances. At the request and sole expense of the Pledgors, the Collateral Agent shall execute and deliver to the Pledgors any such additional documents as the

Pledgors may reasonably request to evidence the termination and release of the Security Interests in the Visionworks Trademarks.
