INTELLECTUAL PROPERTY SECURITY AGREEMENT

*John* THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (“*Agreement*”), dated as of the 27 day of November, 2017 (the “*Effective Date*”), is made and entered into by and between Universal Trailer Holdings Corp., a Delaware corporation (the “*UTHC*”), Universal Trailer Corporation, a Delaware corporation (“*UTC*”), Universal Trailer Cargo Group, Inc., a Delaware corporation (“*UTCG*”), Exiss Sooner, LLC, a Delaware limited liability company (“*Exiss*”), Featherlite, Inc., a Minnesota corporation (“*Featherlite*”), Universal Trailer Acceptance Corp., a Delaware corporation (“*UTAC*”), Sooner Trailer Manufacturing Company, LLC, a Delaware limited liability company (“*Sooner*”), Universal Trailer of Indiana, LLC, a Delaware limited liability company (“*UTP*”), Universal Trailer of Oklahoma, LLC, a Delaware limited liability company (“*UTO*”), Universal Trailer of Pennsylvania, LLC, a Delaware limited liability company (“*UTP LLC*”), Universal Trailer of Pennsylvania, L.P., a Delaware limited partnership (“*UTP LP*”), Universal Trailer Sales Company, LLC, a Delaware limited liability company (“*UTSC*”), Internet Trailer, Inc., a Delaware corporation (“*Internet*”), and Universal Freight Express, LLC, a Delaware limited liability company (“*UFE*”, and together with UTHC, UTC, UTCG, Exiss, Featherlite, UTAC, Sooner, UTI, UTO, UTP LLC, UTP LP, UTSC, and Internet, collectively, the “*Grantors*”, and each individually, a “*Grantor*”) and KeyBank National Association, a national banking association (“*Lender*”).

**WITNESSETH:**

WHEREAS, Lender has provided certain financial accommodations to Grantors (the “*Loans*”), pursuant to the terms and conditions of that certain Loan Agreement dated as of June 3, 2015 by and among the Lender and the Grantors (the “*Loan Agreement*”);

WHEREAS, capitalized terms used and not otherwise defined herein shall have the meaning set forth in the Loan Agreement;

WHEREAS, to induce the Lender to make the Loans, Grantors granted a security interest in substantially all of the Grantors’ assets, including the IP Collateral (as defined below), pursuant to the terms and conditions of that certain Security Agreement dated as of June 3, 2015 by and among the Lender and the Grantors (the “*Security Agreement*”);

WHEREAS, Borrower has agreed to execute this Agreement with respect to the perfection of the IP Collateral; and

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

**AGREEMENT**

1. Grant of Security. Each Grantor hereby pledges and grants to the Lender a security interest in and to all of the right, title and interest of such Grantor in, to and under the following (the “*IP Collateral*”):

(a) the patents and patent applications set forth in Schedule 1 hereto and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the "*Patents*");

(b) the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (the "*Trademarks*");

(c) the copyright registrations, applications set forth in Schedule 3 hereto, and all extensions and renewals thereof (the "*Copyrights*");

(d) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation. Each Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government officials to record and register this Agreement upon request by the Lender.

3. Loan Documents. This Agreement has been entered into pursuant to the Loan Agreement and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Lender with respect to the IP Collateral are as provided by the Loan Agreement, the Security Agreement and the Loan Documents, and nothing in this Agreement shall be deemed to limit such rights and remedies.

4. Execution in Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or in electronic (i.e., "pdf" or "tif") format shall be effective as delivery of a manually executed counterpart of this Agreement.

5. Successors and Assigns. This Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.


