**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of November 30, 2017, is made by Credit Suisse AG, Cayman Islands Branch, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties, in favor of the Borrower (as defined below) in connection with the Trademark Security Agreement, dated as of October 13, 2016 between the Borrower and the Collateral Agent (the "Second Lien Trademark Security Agreement", as amended, amended and restated, supplemented or otherwise modified from time to time). Capitalized terms used herein without definition have the meanings set forth in the Second Lien Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to (i) that certain Security Agreement (Second Lien) dated as of October 13, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Second Lien Security Agreement"), among Harbortouch Payments, LLC (n/k/a Lighthouse Network, LLC), a Delaware limited liability company (the "Borrower"), each other Grantor from time to time party thereto and the Collateral Agent for the Secured Parties and (ii) the Second Lien Trademark Security Agreement, the Borrower assigned and pledged to the Collateral Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, and granted to the Collateral Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, a continuing security interest in all of the Borrower's right, title and interest in (a) the Trademark registrations and applications set forth on Schedule I hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby or associated therewith, and (b)(i) all extensions and renewals thereof, (ii) all income, fees, royalties, damages and payments now and hereafter due and/or payable with respect to any of the foregoing, including damages, claims and payments for past, present or future infringements or dilutions thereof, and (iii) all rights to sue for past, present and future infringements or dilutions thereof (collectively, the "Trademark Collateral");

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on October 14, 2016 at Reel 5899, Frame 0623; and

WHEREAS, the Collateral Agent is, pursuant to (i) that certain payoff letter dated as of the date hereof among Credit Suisse AG, Cayman Islands Branch, as Agent (as defined therein) and the Borrower and (ii) this Termination and Release, terminating, releasing and discharging the entirety of its continuing security interest in the Trademark Collateral in accordance with Section 7.11 of the Second Lien Security Agreement.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks

pursuant to the Second Lien Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its continuing security interest in all of the Borrower's right, title or interest in, to and under all of the Trademark Collateral, and any right, title or interest of the Collateral Agent or any other Secured Party therein shall hereby cease and become void.

2. Further Assurances. The Collateral Agent shall, at the expense of the Borrower, execute and deliver to the Borrower all further releases and other documents (including, without limitation, Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the security interest in respect of the Trademark Collateral, in each case as reasonably requested by the Borrower.

3. Applicable Law. **THIS TERMINATION AND RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.**

4. Electronic Delivery. Delivery of an executed page to this Termination and Release by facsimile transmission or other customary means of electronic transmission (e.g., "pdf") shall be effective as delivery of a manually signed Termination and Release.

5. Miscellaneous. The execution and delivery of this Termination and Release and any document or agreement referred to herein or in connection herewith, and the taking of any action in connection herewith shall be without recourse to, or representation or warranty by, the Collateral Agent or any other Secured Party. Nothing herein shall be construed to act as a release of, or prejudice the rights of the Collateral Agent or the Secured Parties to, the security interest created under any Security Document, other than in respect of the assets being released hereunder.






