**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the “Release”) dated as of November 30, 2017 is made by ANTARES CAPITAL LP (“Antares”, as successor in interest to General Electric Capital Corporation), as administrative agent (in such capacity, the “Administrative Agent”) in favor of ENTRAVISION COMMUNICATIONS CORPORATION, TODOBEBE, LLC, and PULPO MEDIA, INC. (collectively, the “Grantors”).

**WITNESSETH**

WHEREAS, (i) Entravision Communications Corporation executed the (a) Trademark Security Agreement dated as of July 27, 2010 (the “July 2010 Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office (“USPTO”) on July 28, 2010 at Reel/Frame No. 4249/0655, (b) Trademark Security Agreement dated as of December 20, 2012 (the “December 2012 Trademark Security Agreement”) and recorded with the USPTO on December 26, 2012 at Reel/Frame No. 4928/0893, (c) Trademark Security Agreement dated as of May 31, 2013 (the “May 2013 Trademark Security Agreement”) and recorded with the USPTO on May 31, 2013 at Reel/Frame No. 5038/0492, (ii) Todobebe, LLC executed the Trademark Security Agreement dated as of May 31, 2013 (the “Todobebe Trademark Security Agreement”) and recorded with the USPTO on May 31, 2013 at Reel/Frame No. 5038/0500, and (iii) Pulpo Media, Inc. executed the Trademark Security Agreement dated as of July 8, 2014 (the “Pulpo Media Trademark Security Agreement” and collectively with the July 2010 Trademark Security Agreement, December 2012 Trademark Security Agreement, May 2013 Trademark Security Agreement, and Todobebe Trademark Security Agreement, the “Trademark Security Agreements”) and recorded with the USPTO on July 9, 2014 at Reel/Frame No. 5319/0342, pursuant to which the Grantors mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements);


WHEREAS, pursuant to the Assignment of Intellectual Property Security Agreement dated as of August 21, 2015 (the “Assignment”) and recorded August 31, 2015 with the USPTO at Reel/Frame No. 5612/0249, General Electric Capital Corporation assigned and transferred to Antares and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreements.

WHEREAS, the Grantors have requested that the Administrative Agent release its Lien on and security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its Lien on and security interest in all right, title and interest in, to and under all of the Trademark Collateral (as defined in the Trademark Security Agreements), including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral (as defined in the Trademark Security Agreements) is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements) under the Trademark Security Agreements and the Assignment.
