RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of this the 30th day of November, 2017, is given by BANK OF AMERICA, N.A., a national banking association (in such capacity, the “Secured Party”), to LAPOLLA INDUSTRIES, INC., a Delaware corporation (the “Grantor”).

W I T N E S S E T H

WHEREAS, the Grantor and the Secured Party, on behalf of the Secured Parties (as defined in the Second Lien Security Agreement), entered into that certain Loan and Security Agreement, dated as of August 31, 2010 (as amended, restated, supplemented, or otherwise modified from time to time, the “Loan and Security Agreement”);

WHEREAS, in connection with the Loan and Security Agreement, the Grantor executed that certain Trademark Security Agreement dated as of August 31, 2010 (as heretofore amended, restated, supplemented or otherwise modified, the “Trademark Security Agreement”), which was duly recorded on September 21, 2010 at Reel 004282/Frame 0464 with the United States Patent and Trademark Office and which was amended by the First Amendment to Trademark Security Agreement, dated as of May 3, 2013, which was duly recorded on June 4, 2013 at Reel 005040/Frame 0359 with the United States Patent and Trademark Office, and granted to the Secured Party a continuing security interest in all right, title and interest of the Grantor in, to and under the Trademarks, Trademark Licenses and Trademark Collateral, as those terms are defined in the Trademark Security Agreement, including the trademarks and service marks listed on the attached Schedule A; and

WHEREAS, the Grantor and the Secured Party wish to release and restore all right, title and interest in and to the Trademarks, Trademark Licenses and Trademark Collateral to the Grantor and to dissolve those liens and encumbrances with respect to the Trademarks, Trademark Licenses and Trademark Collateral created by the Trademark Security Agreement and any other agreement made in connection with the Loan and Security Agreement.


