**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of November 29, 2017 is made by SUPER G CAPITAL, LLC, a Delaware limited liability company, as ("Lender"), under that certain Intellectual Property Security Agreement, made as of June 8, 2017, by MUSE PAINTBAR, LLC, a Delaware limited liability company ("Borrower"), in favor of the Lender (as amended, supplemented or modified and in effect from time to time, the "Intellectual Property Security Agreement").

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Borrower granted a security interest to the Lender in certain intellectual property collateral including the Trademarks set forth on Schedule 1 thereto (the "Trademark Collateral"); and

WHEREAS, an executed copy of the Intellectual Property Security Agreement was recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on July 20, 2017 at Reel 6110, Frame 0073; and


WHEREAS, the Lender has agreed to terminate and release its security interest in all of such Trademark Collateral, including, without limitation, the Trademarks (as defined in the Intellectual Property Security Agreement) identified on Schedule A attached hereto, being the same Trademarks set forth on Schedule 1 to the Intellectual Property Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Intellectual Property Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the Trademark Collateral.


