## FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

This Full Release and Reconveyance of Security Interests is granted by Wells Fargo Bank, National Association (hereinafter, the "Administrative Agent"), in favor of Texas Taco Cabana, L.P., (the "Pledgor"). Unless otherwise defined herein, capitalized terms used herein have the meaning given to them in that certain Security Agreement, dated as of December 11, 2013, in favor of the Administrative Agent by the Pledgor and the other parties from time to time party thereto.


WHEREAS, the Pledgor granted to the Administrative Agent a security interest in the Trademarks listed on the attached Schedule A, the Goodwill associated with such Trademarks and all of the Proceeds of any and all of the foregoing (other than Excluded Property) (hereinafter collectively referred to as the "Collateral") under that certain Trademark Security Agreement dated as of December 11, 2013, recorded with the U.S. Patent and Trademark Office on December 11, 2013 at Reel/Frame No. 5171/0555 (the "Security Interest");

NOW, THEREFORE, in consideration of the fulfillment of certain covenants made by the Pledgor, and having full authority to do so, the Administrative Agent hereby forever releases and discharges its Security Interest in the Collateral and reconveys to the Pledgor, to the extent of its interest therein, the Collateral, without recourse.

This Full Release and Reconveyance of Security Interests shall be governed by and construed in accordance with the laws of the State of New York without regard to any principles of conflicts of law.
