**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of December 1, 2017, by **BLACKROCK CAPITAL INVESTMENT CORPORATION**, a Delaware corporation (in such capacity, together with its successors and assigns in such capacity, “Collateral Agent”) in favor of **SUPERIOR VISION BENEFIT MANAGEMENT, INC.**, a New Jersey corporation with an address at 939 Elkrigde Landing Road, Suite 200, Linthicum, Maryland 21090 and **SUPERIOR VISION SERVICES, INC.**, a Delaware corporation with an address at 11101 White Rock Road, Suite 150, Rancho Cordova, California 95670 (collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain second lien trademark security agreement dated March 31, 2016 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on April 4, 2016 at the United States Patent and Trademark Office at Reel 5764, Frame 0652.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, as security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantors granted to the Collateral Agent, its successors and assigns a security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of their Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest.
