TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Release"), dated this 1st day of December, 2017, is by JPMORGAN CHASE BANK, N.A., a national banking association (the "Secured Party").

A. ***WHEREAS***, THINADDICTIVES INC., a corporation organized under the federal laws of Canada ("Grantor"), granted Secured Party a security interest in its trademarks including those listed on Schedule I hereto (collectively, the "Trademarks");

NOW, THEREFORE, FOR VALUE RECEIVED, Secured Party agrees as follows:

1) Secured Party does hereby terminate and release its security interest in and to the Trademarks, all renewals thereof, all goodwill of the business symbolized by each, all other rights therein of any type or description, and all proceeds of the foregoing.

2) Secured Party hereby authorizes Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish Secured Party's rights and interest in the Trademarks.

3) This Release is governed by the laws of the State of Illinois, excluding its choice of law principles to the contrary.

4) This Release shall be binding upon Secured Party and its successors and assigns and inures to the benefit of Grantor and its successors and assigns.

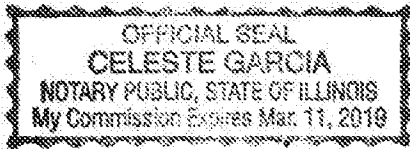
