RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of December 1, 2017, by REGIONS BANK, an Alabama corporation, as secured party ("Secured Party"), and CMP Pharma, Inc., a North Carolina corporation, and CMP Acquisition Company LLC, a Delaware limited liability company (the "Debtors").
