**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of August 9, 2013 and made by **H.I.G. WONDER HOLDINGS, LLC**, a Delaware limited liability company, as Lender, located at 1450 Brickell Avenue, 31st Floor, Miami, FL 33131 ("Grantee") to **MATRIX INITIATIVES, INC.**, a Delaware corporation ("Grantor"), located at 8515 E. Anderson Drive, Scottsdale, AZ 85255.

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of June 27, 2012, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 29, 2012, at Reel/Frame 4811/0227; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
