## RELEASE OF TRADEMARK SECURITY INTEREST

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

Agent hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademarks, including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
