**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of October 17, 2012, is made by UBS AG, STAMFORD BRANCH, as US Collateral Agent (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Amended and Restated Credit Agreement dated as of October 25, 2010 (the "**Credit Agreement**"), among SOUTHERN GRAPHIC SYSTEMS - CANADA, CO./SYSTEMES GRAPHIQUES SOUTHERN - CANADA, CO., an unlimited liability company organized under the laws of Nova Scotia ("**Canadian Borrower**"), SGS INTERNATIONAL, INC., a Delaware corporation ("**US Borrower**", and together with Canadian Borrower, the "**Borrowers**" and each individually, a "**Borrower**"), the Guarantors, the Lenders, UBS SECURITIES LLC and FIFTH THIRD BANK, as joint lead arrangers, UBS SECURITIES LLC, as syndication agent, JPMORGAN CHASE BANK, N.A., as documentation agent, UBS LOAN FINANCE LLC, as swingline lender, and Agent, the Lenders made loans and other financial accommodations to the Borrowers;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrowers and the Guarantors (together, the "**Grantors**") granted security interests in certain intellectual property owned by Grantors including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on the dates and on the reels and frames set forth on Annex I hereto.

NOW THEREFORE, the Agent hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral granted pursuant to the Security Agreements and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Grantors.


The Agent agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.


