TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 4, 2017, is made by MORGAN STANLEY SENIOR FUNDING, INC., as Collateral Agent (the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement dated as of December 2, 2014 (as amended, restated, amended and restated, modified or supplemented from time to time), among WHISTLE MERGER SUB II, LLC, a Delaware limited liability company, WHISTLE MERGER SUB III, LLC, a Delaware limited liability company, the Lenders party thereto from time to time, MORGAN STANLEY SENIOR FUNDING, INC., as the Administrative Agent and the Collateral Agent, and the other agents and arrangers party thereto), in favor of Packers Sanitation Services, Inc., Ltd. (the "Grantor").

WHEREAS, Grantor has granted a security interest in certain personal property to the Collateral Agent, for the benefit of the Secured Parties, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks") pursuant to that certain Trademark Security Agreement dated as of December 2, 2014 (the "Agreement") by Grantor in favor of Collateral Agent for the Secured Parties;

WHEREAS, the Agreement was recorded at the United States Patent and Trademark Office on December 2, 2014 at Reel 5411 and Frame 0611 and corrected on February 6, 2015 at Reel 5454 and Frame 0896; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in any of the Grantor's Trademark Collateral (as defined in the Agreement).


