PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 24th day of October, 2017, by THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation, as successor by merger to THE CIT GROUP/CREDIT FINANCE, INC., a Delaware corporation (“CIT Group”), in favor of FITZ AND FLOYD ENTERPRISES, LLC, a Delaware limited liability company, as successor in interest to Seasons, Inc., an Arkansas Corporation (“Company”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, CIT Group hereby releases its liens on and security interests in the Patent Collateral, Trademark Collateral, and License Collateral (as defined in the Security Agreement referred to below), including the trademarks listed on Exhibit A attached hereto and made a part hereof, which liens and security interests were established under and pursuant to that certain Grant of Security Interest in Patents, Trademarks and Licenses, dated March 31, 1998, executed by the Company in favor of CIT Group and recorded with the United States Patent and Trademark Office on June 3, 1998 at Reel/Frame 1736/0277 (the “Security Agreement”).
