THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 14<sup>th</sup> day of November, 2017, by THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation (“CIT Group”), in favor of FITZ AND FLOYD ENTERPRISES, LLC, a Delaware limited liability company, as successor in interest to FITZ AND FLOYD, INC., f/k/a FFSC, INC., a Delaware corporation (“Company”).
