TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of November 21, 2017, is made by Cortland Products Corp. (f/k/a Gleacher Products Corp.), as Agent (in such capacity, the "Agent"), in favor of Trailer Bridge, Inc. (the "Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below), and, for the avoidance of doubt, "Trademark Collateral" shall include, without limitation, those United States Trademarks and Trademark Applications listed on Schedule 1 attached hereto.

WHEREAS, pursuant to that (i) certain Security Agreement, dated as of April 2, 2012 (as it may be amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement") between the Grantor and the Agent and (ii) certain Short-Form Trademarks Security Agreement, dated as of April 2, 2012 (the "Trademark Security Agreement") executed by the Grantor in favor of the Agent, the Grantor pledged and granted to the Agent a security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Agent has agreed to terminate, release and discharge its security interest and lien on all of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantor secured by the Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby terminates, releases and discharges all of its mortgages, liens, and security interests in all of the Grantor's right, title and interest in, to and under the Trademark Collateral and hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral to the Grantor.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. **THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.**
