ARTICLES OF CHARTER SURRENDER
OF
ORBIS EDUCATION SERVICES, INC.

Pursuant to IND. CODE 23-1-38.5-14 the above-referenced Indiana corporation desiring to effect a conversion to a Delaware limited liability company, hereby sets forth and represents the following:

ARTICLE I

The name of the Indiana corporation immediately prior to filing these Articles of Charter Surrender is *Orbis Education Services, Inc.* (the "Company").

ARTICLE II

These Articles of Charter Surrender are being filed in connection with the conversion of the Company to *Orbis Education Services, LLC*, a Delaware limited liability company.

ARTICLE III

The above-referenced conversion of the Company was duly approved by the Board of Directors pursuant to a Unanimous Written Consent of the Board of Directors dated as of August 26, 2012 and by the shareholders of the Company pursuant to a Written Consent of the Shareholders dated as of August 30, 2012, as required by the provisions of the Indiana Business Corporation Law, the Third Amended and Restated Articles of Incorporation of the Company, as amended, and the Bylaws of the Company.

ARTICLE IV

The surviving entity, *Orbis Education Services, LLC*, will be organized under the laws of the State of Delaware.

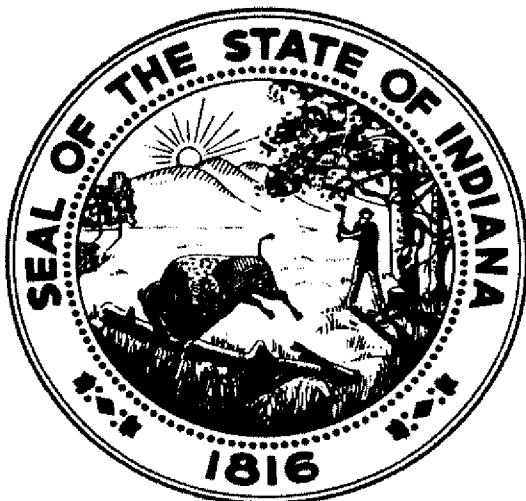
