RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (the “Release”), dated as of December 7, 2017, is made by HCP-FVF, LLC, a Delaware limited liability company, as collateral agent for itself and the Purchasers (as defined in the Note Purchase Agreement, defined below) (the “Collateral Agent”), in favor of NUMEREX CORP. (“Borrower”), a Pennsylvania corporation, OMNILINK SYSTEMS INC., a Delaware corporation and UPLINK SECURITY, LLC, a Georgia limited liability company (each individually, a “Grantor” and collectively, the “Grantors”).

WHEREAS, Borrower, the various Guarantors (as defined therein) from time to time party thereto, the Collateral Agent and each Purchaser party thereto entered into that certain Note Purchase Agreement, dated as of June 7, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Note Purchase Agreement”). Capitalized terms used and not otherwise defined herein shall have the meanings given such terms in the Note Purchase Agreement.

WHEREAS, the Grantors, among others, have executed and delivered in favor of the Purchasers and the Collateral Agent that certain Guaranty and Collateral Agreement, dated as of June 7, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

WHEREAS, under the terms of the Security Agreement, each Grantor granted to the Collateral Agent, for the ratable benefit of the Purchasers and the Collateral Agent, a continuing security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in and to the following (the “Trademark Collateral”):

(1) the trademark and service mark registrations and applications set forth on Schedule A attached hereto, together with the goodwill symbolized thereby (collectively, the “Trademarks”);

(2) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(3) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(4) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral or arising from any of the foregoing), pursuant to, among other things, that certain Intellectual Property Security Agreement, dated as of June 7, 2017 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the

“Agreement”), which was filed at the United States Patent and Trademark Office on June 8, 2017 and recorded on Reel 6079, Frame 0350.

WHEREAS, the Collateral Agent has agreed to terminate the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

SECTION 1. Termination and Release. The Collateral Agent hereby terminates, releases, discharges, waives and relinquishes fully, without representation, warranty or recourse of any kind, its security interest in and to the Trademark Collateral, and reassigns and transfers to the Grantors any and all right, title and interest in the Trademark Collateral that the Collateral Agent may have in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable Governmental Authority record this Release.

SECTION 3. Execution in Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Further Assurances. The Collateral Agent agrees that, upon the reasonable request of the Grantors, and at the Grantors’ sole cost and expense, the Collateral Agent will execute any document, cause to be made any filing or take any other action that the Grantors (or their respective agents or designees) reasonably request, to confirm this Release and the Grantors’ right, title and interest in the Trademark Collateral.

SECTION 5. Governing Law. This Release shall be governed by, construed in accordance with, and enforced under, the laws of the State of New York, without regard to the principles of conflicts of law of such state that would require the application of the law of another jurisdiction.


