INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT
FOR BUYER 1

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment"), dated as of the Closing Date (the "Effective Date"), is made and entered into by and between OMP, Inc., a corporation formed under the laws of the State of Delaware ("OMP"), and Obagi Medical Products, Inc., a corporation formed under the laws of the State of Delaware (together with OMP, the "Assignor"), and Obagi Cosmeceuticals LLC, a limited liability company formed under the laws of the State of Delaware (the "Assignee" or "Buyer 1"). The Assignor and the Assignee are each referred to individually as a "Party" and collectively as the "Parties."

RECITALS

WHEREAS, Valeant Pharmaceuticals Ireland, Valeant Pharmaceuticals North America LLC, and Obagi Medical Products, Inc. (collectively, the "Seller"), on the one hand, and Buyer 1, Obagi Holdings Company Limited, and Haitong International ZhongHua Finance Acquisition Fund I, L.P., on the other hand, have entered into that certain Amended and Restated Asset Purchase Agreement, executed and delivered on October 31, 2017 (the "Asset Purchase Agreement"); and

WHEREAS, pursuant to the Asset Purchase Agreement, Assignee has agreed to purchase certain assets of Assignor, and Assignor has agreed to cause the same to be sold, conveyed, delivered, transferred and assigned to Assignee, including the Transferred Intellectual Property other than Buyer 2 Transferred Intellectual Property, as such term is defined in the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the foregoing and the respective representations, warranties, covenants and agreements set forth herein, and for other good and valuable consideration including the consideration set forth in the Asset Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. Definitions. Capitalized terms used but not otherwise defined herein have the meanings set forth in the Asset Purchase Agreement.
2. Assignment. Assignor, on its behalf and on behalf of its Affiliates, hereby transfers and assigns to Assignee, and Assignee hereby accepts, all right, title and interest in and to such Transferred Intellectual Property other than Buyer 2 Transferred Intellectual Property, as identified in Schedule A, Schedule B, Schedule C and Schedule D attached hereto owned by Assignor and/or each of its Affiliates, as follows:
 - (a) the Patents specifically identified in Schedule A attached hereto, as such term is defined in the Asset Purchase Agreement;

(b) the (1) Trademark Registrations specifically identified in Schedule B attached hereto, as such term is defined in the Asset Purchase Agreement, and (2) Trademarks not included in such Trademark Registrations, other than as included in the Buyer 2 Transferred Intellectual Property, to the extent such Trademarks are transferable, or reasonably practicable to transfer, in light of legal, contractual or other practical considerations, as determined by Seller in its reasonable judgment;

(c) the Copyright Registrations specifically identified in Schedule C attached hereto, in each case, to the extent transferable, or reasonably practicable to transfer, in light of legal, contractual or other practical considerations, as determined by Seller in its reasonable judgment;

(d) the Domain Name Registrations specifically identified in Schedule D attached hereto; and

(e) for the avoidance of doubt, in each case of (a)-(d) of this Section 2, the Transferred Intellectual Property other than Buyer 2 Transferred Intellectual Property includes all rights to any Actions of any nature available to or being pursued by Seller to the extent related to the foregoing, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive relief for infringement, dilution, misappropriation, violation, misuse, breach or default, with the right, but not the obligation, to sue for such legal and equitable relief, and to collect, or otherwise recover, any such damages.

3. Assignor's Undertaking. Assignor agrees to execute and deliver or cause to be executed and delivered to Assignee, at Assignee's expense (but without further compensation to Assignor), such further instruments of transfer and conveyance and to take or cause to be taken such other actions as may reasonably request to carry out the transfer of the Transferred Intellectual Property conveyed herein.




