## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made this 13 day of November, 2017, by and between John G. Hondros, an individual ("Hondros"), Hondros Learning, LLC, an Ohio limited liability company (the "Assignor") and Compucram.com LLC, an Ohio limited liability company (the "Assignee").

WHEREAS, on March 2, 2015, Hondros assigned the ownership rights to the trademark COMPUCRAM (word mark), Reg. #2065612 to Hondros Learning, LLC pursuant to the first Trademark Assignment attached hereto as Exhibit A (the "First Assignment");

WHEREAS, pursuant to the First Assignment, Assignor is the owner of all right, title and interest in and to the trademark and the corresponding registration and/or application for registration set forth on Exhibit B (the "Trademark"), together with the goodwill of the business connected with and symbolized by the Trademark;

WHEREAS, at the time of the assignment to Assignor, Hondros failed to notify the United States Patent and Trademark Office of the First Assignment;

WHEREAS, contemporaneous with the execution of this Assignment, Hondros, at the direction of Assignor, executed a Trademark Assignment Recordation Form recorded with the United States Patent and Trademark Office to notify the United States Patent and Trademark Office of the assignment of the Trademark to Assignee; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor hereby assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademark (including, without limitation, the right to renew the registration included in the Trademark, the right to apply for a trademark registration within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademark); the business to which the Trademark pertains; all income, royalties, damages and payments in respect of the Trademark; and all causes of action in law or equity arising out of the above items, including but not limited to all rights to sue, counterclaim and recover damages for infringement; the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made.

Hondros and Assignor authorize the Commissioner of Trademark of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registration and/or applications for registration set forth on Exhibit B to Assignee as assignee of Assignor's entire right, title and interest therein. Hondros and/or Assignor agree to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademark.

This Trademark Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

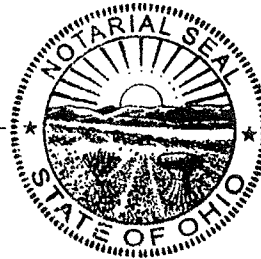

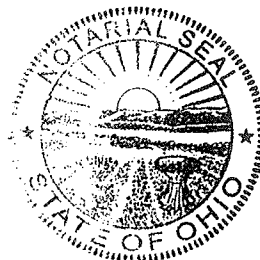

Assignor's ownership of the Mark includes but is not limited to common law rights, trade name rights, and the right to recover for past infringement, in the United States and in other countries.


Assignor has created and is using all the goodwill associated with and symbolized by the Mark and has not abandoned same.
