RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS

WHEREAS, pursuant to that certain Grant of A Security Interest – Trademarks (the "Trademark Security Agreement"), dated as of October 16, 2012, recorded in the United States Patent and Trademark Office on October 17, 2012 at Reel 004883, Frame 0065, Marine Acquisition (US) Incorporated (f/k/a TFX Marine Incorporated) ("Releasee") granted to Ableco Finance LLC ("Releasor"), in its capacity as Collateral Agent for itself and certain lenders, a continuing security interest in all right, title and interest of the Releasee in, to and under the Trademarks, including the Trademarks listed on Schedule A attached hereto, together with, among other things the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
