**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 7, 2017 ("Release"), is made by Bank of America, N.A., as Collateral Agent ("Collateral Agent") in favor of Millennium Pharmacy Systems, LLC, a Delaware limited liability company ("Loan Party").

**WHEREAS**, pursuant to that certain Guarantee and Collateral Agreement dated as of September 17, 2014 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Collateral Agreement") by and among the Loan Party, Collateral Agent, and others party thereto, and the Patent and Trademark Security Agreement dated as of October 27, 2014 by and among the Loan Agent and Collateral Agent ("IP Security Agreement"), Loan Party assigned and pledged to the Collateral Agent, its successors and permitted assigns for the benefit of the Secured Parties, and granted to the Collateral Agent, its successors and permitted assigns for the benefit of the Secured Parties, a security interest in, all right, title and interest in, to, and under any and all Patent and Trademark Collateral; and

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on November 6, 2014 at Reel 5395 Frame 0969.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Loan Party agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to, and the right to set off against, Loan Party's right, title, and interest in, to, and under all the Patent and Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or IP Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Loan Party's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
