**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 5, 2017 (“Release”), is made by Enterprise Bank & Trust, a Missouri chartered trust company (“Lender”) in favor of iPremise, LLC, a Colorado limited liability company (“Grantor”).

**WHEREAS**, pursuant to that certain Loan and Security Agreement dated as of May 11, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Agreement”) by and among the Grantor, Lender, and others party thereto, Grantor granted to the Lender a security interest in, and a lien on, any and all of Grantor’s right, title and interest in and to all trademarks, trademark rights, trade names, trade name rights, including, but not limited to, the foregoing listed on Schedule A attached hereto, together with all goodwill, income, royalties, damages and payments now and hereafter due and payable thereunder and with respect thereto (collectively, “Trademark Collateral”); and

**WHEREAS**, pursuant to the Agreement, Grantor executed and delivered to Lender the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on May 15, 2017 at Reel 6058 Frame 0379 (“Notice”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Agreement or Notice.

**SECTION 2. Termination and Release.** Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, and discharges the Notice, and releases the security interest in, and a lien on, any and all right, title and interest in and to all Trademark Collateral, granted pursuant to the Agreement; and




(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Missouri.
