TRADEMARK ASSIGNMENT

This Trademark Assignment, effective as of December 12, 2017 ("Effective Date"), is by Pacific Foods of Oregon, LLC, an Oregon limited liability company ("Assignor"), in favor of Charles W. Eggert, an individual ("Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Securities Purchase Agreement (the "Purchase Agreement") dated July 6, 2017 by and among Assignor, Assignee, the shareholders of Assignor, Charles W. Eggert, as shareholder representative, and Campbell Investment Company, a Delaware corporation;

WHEREAS, Campbell Investment Company has assigned all of its rights and delegated all of its obligations under the Purchase Agreement to its wholly owned subsidiary, Pacific Foods Investments, Inc., a Delaware Corporation ("Buyer"); and

WHEREAS, under the Purchase Agreement, Charles W. Eggert is selling all of his interest in Assignor, but desires to retain ownership and use of the Trademarks (as defined herein), and Buyer has agreed to allow Assignor to transfer the Trademarks to Charles W. Eggert on or before the Closing Date (as that term is defined in the Purchase Agreement).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees as follows:

1. Assignor hereby irrevocably assigns, transfers, conveys and delivers to Assignee, on an "as is" basis, without express or implied representations or warranties of any kind, all of its right, title and interest throughout the world in and to each of the trademarks listed on Exhibit A, together with the goodwill of the business associated with such trademarks, and the identified applications and registrations for such trademarks (collectively, the "Trademarks").

2. Assignor hereby acknowledges and agrees that from and after the Effective Date, Assignee, as the successor to the portion of the business to which the Trademarks pertain, will be the exclusive owner of all of Assignor's right, title and interest in and to the Trademarks.

3. At Assignee's reasonable request, Assignor will take all further actions and execute any additional agreements and instruments as may be necessary to effect the assignment contemplated by this Trademark Assignment, to perfect Assignee's title in and to the Trademarks, and to allow Assignee to file and record this Trademark Assignment with the United States Patent and Trademark Office and all applicable foreign intellectual property offices, as may be necessary to effectuate the assignment and transfer of the Trademarks from Assignor to Assignee.

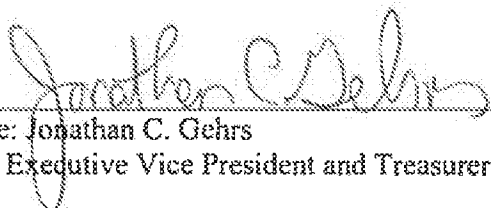
