**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY (SECOND LIEN TRADEMARKS)**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (SECOND LIEN TRADEMARKS)** (the “Release”), dated as of December 7, 2017, is made by Antares Capital LP, a Delaware limited partnership, as Administrative Agent (the “Administrative Agent”), pursuant to the Second Lien Credit Agreement, dated as of August 6, 2012 (as amended, supplemented, extended, restated, or otherwise modified from time to time, the “Credit Agreement”) and the Second Lien Guaranty and Security Agreement dated as of August 6, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WITNESSETH

WHEREAS, each of (i) Velocity Technology Solutions, Inc., a Delaware corporation, (ii) Velocity Technology Solutions V, Inc. (f/k/a Titan Technology Partners, Limited), a North Carolina corporation, and (iii) Velocity Technology Solutions IV, Inc., a Colorado corporation (each, a “Grantor” and collectively, the “Grantors”), is a party to the Credit Agreement and the Security Agreement;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, each Grantor executed and delivered to the General Electric Capital Corporation (“GECC”), as administrative agent and collateral agent and predecessor-in-interest to the Administrative Agent that certain Trademark Security Agreement dated as of March 28, 2014 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on March 31, 2014 at Reel/Frame No. 5247/0489, pursuant to which each Grantor granted to GECC a security interest in its Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to that certain (i) Omnibus Agency Transfer Agreement, dated as of August 21, 2015, by and between GECC and the Administrative Agent and (ii) Assignment of Intellectual Property Security Agreements, dated of August 21, 2015, by and between GECC and the Administrative Agent and recorded with the USPTO on August 24, 2015 at Reel Frame No. 5607/0457, GECC assigned to the Administrative Agent all of its rights, remedies, duties and other obligations under, *inter alia*, the Trademark Security Agreement in its capacity as administrative agent and, if applicable, collateral agent;

WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, each Grantor has requested that the Administrative Agent release its security interest in all of its right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES its security interest in all right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademarks (as defined in the Trademark Security Agreement) set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to each Grantor any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Credit Agreement and the Security Agreement.
