## PARTIES

**ManukaMed Limited**, a New Zealand company, of 17 Edwin Feist Place, Masterton, New Zealand (the Assignor); and

**Watson & Son Limited** a New Zealand company, of 17 Edwin Feist Place, Masterton, New Zealand (the Assignee).

## BACKGROUND

The Assignor is the owner of various Intellectual Property Rights, which it has created and used in the development and production of its honey wound care products, over the counter products including honey and honey science research (the Business).

The Assignor is being restructured into a new entity.

The Assignor has resolved to assign to the Assignee, and the Assignee has agreed to accept, all rights to the Intellectual Property Rights in the Business under the terms set out in this Deed.

## TERMS

### Definitions

**Copyright** means all copyrights and all rights in the nature of copyright in any original artistic, literary or other work and any database rights comprising or relating to the Business that exist anywhere in the world, including but not limited to the Copyright works specified in the Schedule to this Deed.

**Domain Names** includes, but is not limited to those domain names specified in the Schedule.

**Patents** means all patent applications and patents listed in the Schedule to this Deed of Assignment and all patent rights in any invention that exists or that may come into existence but not limited to the right to apply for and obtain patents or other similar forms of protection for inventions, the right to claim convention priority under any international convention or agreement (including the Paris Convention), and all rights conferred by any patents or similar forms of protection when granted.

**Intellectual Property Rights** means all intellectual property rights, whether protectable by statute, at common law or in equity, that exist anywhere in the world, whether or not registered or registrable

and including but not limited to the Trade Marks, the Patents the Copyright, the Know-how and the Domain Names detailed in the Schedule to this Deed.

**Know-How** means any information that is known to the Assignor that has arisen from the research and development it has undertaken or sponsored, including clinical trials, medical honey specifications on wound care manufacturing and production, packaging and sale of wound care and over the counter products containing honey and any other associated information in the Business and including but not limited to the Know-How specified in the Schedule to this Deed.

**Trade Marks** includes those registered and unregistered trademarks listed in the Schedule to this Deed of Assignment and common law trade marks that are used in the Business and any good will associated with the Trade Marks or the Business.

#### **ASSIGNMENT**

At the request of the Assignee, the Assignor undertakes to do any reasonable acts, including signing of all documents, that may be necessary to give effect to this assignment of rights and to facilitate the filing, obtaining, maintenance or enforcement of protection of the Intellectual Property Rights.



**Governing Law**


