

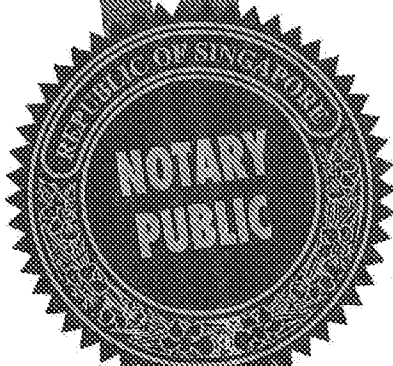

DEED OF ASSIGNMENT

THIS ASSIGNMENT is made on 6 November 2017

BETWEEN:

- (1) **WILMAR NATURE PTE. LTD.** (Company Registration No. 201617115Z), a company incorporated in Singapore and having its office at 56 Neil Road, Singapore 088830 (hereinafter referred to as the "Assignor");

AND

- (2) **WILMAR TRADING PTE. LTD.** (Company Registration No. 198802023W), a company incorporated in Singapore and having its office at 56 Neil Road, Singapore 088830 (hereinafter referred to as the "Assignee").

WHEREAS:

- A. The Assignor is the proprietor of the registered trade marks as set out in Schedule A ("**Trade Marks**") and pending trade mark applications as set out in Schedule B ("**Trade Mark Applications**") respectively, attached to this Deed of Assignment ("**Deed of Assignment**").
- B. The Assignor is desirous of assigning the Trade Marks and Trade Mark Applications to the Assignee and the Assignee has agreed to accept such assignment upon the terms and conditions set out in this Deed of Assignment.

IT IS HEREBY AGREED AS FOLLOWS:

1. Pursuant to this Deed of Assignment and in consideration of the sum of United States Dollar [REDACTED] only (USD [REDACTED]) now paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledged), the Assignor hereby assigns, with effect from 10 October 2017 (the "**Effective Date**"), to the Assignee with the full title and legal and beneficial rights, title and interest in and to the Trade Marks and Trade Mark Applications, including without limitation, all statutory and common law rights, privileges and advantages attaching thereto together with any goodwill attaching to the Trade Marks and Trade Mark Applications (including all devices, signs, and symbols where used as trade marks belonging to or used by them) to hold unto the Assignee absolutely free from encumbrances.
2. The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Marks and Trade Mark Applications and the goodwill of the business in which the Trade Marks and Trade Mark Applications have been used by the Assignor or its licensees (if any).

3. This Assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks and/or Trade Mark Applications (including proceedings against any third party for infringement or for passing off in respect of the Trade Marks and/or Trade Mark Applications or for otherwise infringing the rights of the Assignor in the Trade Marks and/or Trade Mark Applications whether before or after the Effective Date) and to retain any damages obtained as a result of such action. The Assignor agrees and undertakes to provide to the Assignee (at its request) all such assistance with any proceedings that may be brought by or against the Assignee against or by any third party in relation to the Trade Marks and/or Trade Mark Applications.

4. The Assignor agrees with the Assignee that at the direction and expense of the Assignee to execute any further documents and to do any such act and thing that the Assignee may reasonably require to enable the Assignee to become registered as the proprietor of the Trade Marks and Trade Mark Applications, and to secure the benefits of the rights hereby assigned.

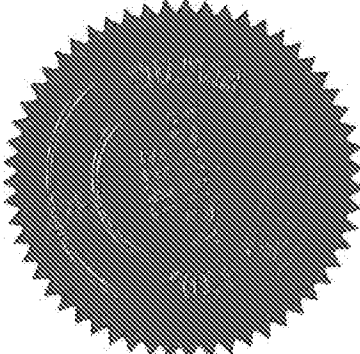
5. The Assignor hereby warrants that:
 - 5.1 it is the proprietor of the Trade Marks and Trade Mark Applications and has the full power to enter into this Assignment;
 - 5.2 the Trade Marks and Trade Mark Applications are free from all charges, liens, equities and encumbrances;
 - 5.3 it has not, either by act or omission caused and permitted anything to be done which might endanger the validity of the Trade Marks and Trade Mark Applications or the ability of the Assignee to register this Assignment; and
 - 5.4 it has not knowingly withheld from the Assignee knowledge of any circumstances that may endanger the validity of the Trade Marks and Trade Mark Applications or the ability of the Assignee to register this Assignment.

6. The Assignor hereby agrees to indemnify, and to keep the Assignee indemnified, against all actions claims proceedings costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisers to compromise or settle any claim) and all legal costs and other expenses arising out of any breach of the warranties as provided in Clause 5 above or out of any claims by a third party based on any facts which if substantiated would constitute such a breach.

7. The Assignee shall bear all fees, costs and disbursements (including stamp duty payable on this Assignment, if any) whatsoever which may be incurred in respect of the assignment of the Trade Marks and Trade Mark Applications to the Assignee. Each party shall bear its own legal costs in respect of the preparation and completion of this Assignment.
8. Any person who is not a party to this Assignment has no right under the Contracts (Rights of Third Parties) Act (Chapter 53B) to enforce any term of this Assignment, but this does not affect any right or remedy of a third party which exists or is available apart from that Act.
9. This Assignment shall be governed by the laws of the Republic of Singapore and the parties hereto submit to the non-exclusive jurisdiction of the Courts of the Republic of Singapore.

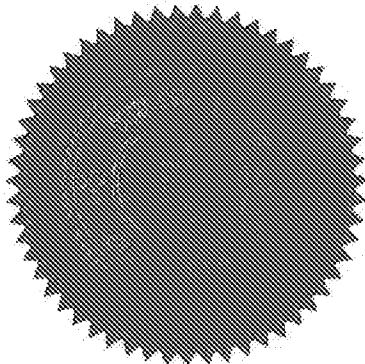
