TRADEMARK ASSIGNMENT

For good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor hereby irrevocably sells, assigns, transfers and delivers to Assignee all of Assignor’s right, title and interest in and to the Trademarks, together with the goodwill of Assignor’s business appurtenant thereto and the ongoing business associated therewith, all registrations and applications (including intent-to-use applications) for the Trademarks in all countries throughout the world, all income, royalties, damages and payments in respect of the Trademarks, and all causes of action for any and all previously occurring infringement of the rights being assigned and the right to receive and retain the proceeds or other remedies relating to those infringements.

3. Further Assurances. Assignor agrees that Assignee shall have the right to file or record this Trademark Assignment with the United States Patent and Trademark Office (“USPTO”) or other such entities throughout the world, and Assignor authorizes and requests the relevant authorities to record Assignee as the assignee and owner of the Trademarks. Assignor agrees to execute such further assignments and documents and to do such other acts as may be necessary or reasonably desirable to vest all of Assignor’s right, title and interest in and to the Trademarks throughout the world in Assignee or as may be necessary or reasonably desirable to obtain, renew, or issue the Trademarks, including instructing the registrar for the Trademarks to transfer the Trademarks to Assignee. In the event that a trademark registrar does not accept or recognize this Trademark Assignment, Assignor hereby agrees that this document shall constitute a request by Assignor to the registrar to transfer the registration of the Trademarks to Assignee.

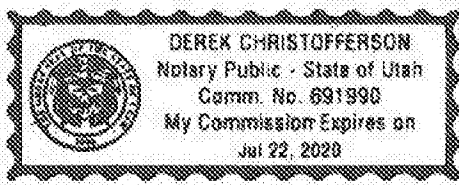
