**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of December 13, 2017, is made between Branch Banking and Trust Company, in its capacity as administrative agent (the "Agent"), and Kauai Coffee Company, LLC (the "Company"), pursuant to the Credit Agreement dated as of September 26, 2012 (as amended, restated, extended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Massimo Zanetti Beverage USA, Inc. as the Borrower (the "Borrower"), the Company, and other guarantors named therein as Guarantors, the lenders from time to time party thereto, the Agent as the Administrative Agent, and BB&T Capital Markets, as the Lead Arranger, and other agents party thereto.

**RECITALS**

WHEREAS, in connection with the Credit Agreement, the Company, the Borrower and other Guarantors party thereto, have executed and delivered, among other documents, (i) a Security Agreement dated as of September 26, 2012 in favor of Agent; and (ii) an IP Security Agreement (Trademarks), dated as of September 26, 2012, recorded in the United States Patent and Trademark Office ("USPTO") on October 5, 2012 at Reel/Frame No. 4887/0405 (collectively, and as amended, restated, extended, supplemented or otherwise modified from time to time, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Company pledged and granted to the Agent and the other Secured Parties (as defined in the Credit Agreement) a continuing security interest in, lien on and right to set-off against, all of Company's right, title and interest in and to the United States trademarks, registrations and applications described in Schedule 1 attached hereto and made a part of this Release (collectively, the "Released Trademarks");

WHEREAS, the Borrower and Agent have mutually decided to terminate the Credit Agreement; and

WHEREAS, in connection therewith, the Company has requested that the Agent release any and all right, title and interest it may have in the Released Trademarks pursuant to the Security Agreements, and the Agent has agreed to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees, for the benefit of the Company, as follows:

**RELEASE**

The Agent releases, relinquishes and discharges its security interest in, lien on and right of set-off against all of the Company's right, title and interest in, to and under the Released Trademarks and all right, title and interest of the Company in the Released Trademarks are hereby reassigned by the Agent to the Company.

The Agent authorizes the Company (i) to record this Release with the USPTO; (ii) file UCC financing statement amendments with the applicable filing office to memorialize the release of the security interest of the Agent in the Released Trademarks; and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Company any additional documentation necessary to effect the release of the security interest of the Agent in the Released Trademarks (without recourse, representation or warranty and at the Company's sole cost and expense).

IN WITNESS WHEREOF, the Agent has caused this Release to be executed by its authorized officer as of the date set forth above.
