## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of December 13, 2017 (“Effective Date”) by HEALTHCARE FINANCIAL SOLUTIONS, LLC, (as successor by assignment from General Electric Capital Corporation), in its capacity as agent (“Grantee”), in favor of ZENITH AMERICAN SOLUTIONS, INC., a Maryland corporation and GEMGROUP, INC., a Pennsylvania corporation (each a “Grantor” and, collectively, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of November 12, 2014 (the “Trademark Security Agreement”), Grantors assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantors’ right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 12, 2014 at Reel 5400, Frame 0236;

WHEREAS, Grantee has agreed to release its lien on all of the Trademark Collateral, including but not limited to the trademarks listed on Schedule 1 hereto (collectively, the “Released Trademark Collateral”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee’s mortgage, pledge, and hypothecation and Lien on and security interest in the Released Trademark Collateral is hereby terminated and released.

2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantors, all of Grantee’s right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Released Trademark Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors. Notwithstanding anything herein to the contrary, nothing herein is intended to modify, limit or otherwise affect the terms set forth in the Pay-Down Letter.

4. Delivery of a photocopy or facsimile or other electronic transmission (e.g., .pdf or .tif file) of an executed counterpart of this Release shall be effective as delivery of a manually executed original counterpart of this Release.

5. The validity, construction and effect of this Release shall be governed by the internal laws of the State of New York (without giving effect to principles of conflicts of law).
