**TRADEMARK ASSIGNMENT**

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of December 14, 2017, (the "Effective Date"), by and between VIP PetCare, LLC, a California limited liability company, having an address of 5813 Skylane Blvd, Windsor, California 95492 ("Assignor") and Community Veterinary Clinics, LLC, a Delaware limited liability company, having an address of 5813 Skylane Boulevard, Windsor, California, 95492 ("Assignee") Assignor and Assignee are sometimes collectively referred to herein as the "Parties."

WHEREAS, Assignee desires to acquire from Assignor all of its rights, title, and interest in the Trademarks and goodwill.

NOW, THEREFORE, incorporating the Recitals, and in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably sells, assigns, grants, conveys, and transfers to Assignee, as of the Effective Date, all of Assignor's rights, title, and interest in and to the Trademarks, (together with the goodwill of the Assignor's business connected with the use of and symbolized by the Trademarks), the registration and all registration rights with respect to the Trademarks, and all rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of said Trademarks or injury to said goodwill, together with the right to sue and recover the same in the name of Assignor.

2. The terms of this Assignment shall bind and inure to the benefit of the Parties hereto and their respective heirs, legal representatives, successors and assigns.

3. The Parties hereby agree to do the following: execute such other documents and perform such other acts as may be necessary or desirable to carry out the purposes of this Assignment. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


