TRADEMARK ASSIGNMENT

Each Assignor consents to the recordation of this Assignment with any governmental agency. Each Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Marks.
