ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS is made effective on the date of execution below by and between Kenneth J. WHEREAS, Assignee desires to acquire the Trademarks and all goodwill associated therewith from Assignor;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign, transfer and set over unto Assignee his entire right, title and interest in and to the Trademarks, together with the goodwill symbolized by and associated with the business in which the Trademarks are used, all income, royalties and payments now or hereafter due or payable in respect thereto, and all causes of action, either in law or in equity, for past, present or future infringement based upon the Trademarks, said interest to be held and enjoyed by Assignee as fully and exclusively as it would have been held and enjoyed by said Assignor had this Assignment and transfer not been made.

2. Assignor hereby covenants, warrants and represents that it has not heretofore granted any license, right or privilege with respect to said Trademarks or in any other way encumbered the same, and that it has the full right to make this Assignment.

3. Assignor shall duly execute and deliver or cause to be executed and delivered all instruments of sale, conveyance, transfer and assignment, and all notices, releases and other documents that may be necessary to more fully grant, convey, transfer, assign and deliver to and vest in Assignee the Trademarks and associated goodwill hereby granted, conveyed, transferred, assigned or delivered or intended so to be.

4. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, his heirs, legal representatives and assigns.
