ASSIGNMENT OF UNITED STATES TRADEMARK

1. Assignor hereby assigns to Assignee all of Assignor's right, title, and interest, including all common law and statutory rights, and any and all federal and state registrations, in and to the Mark, together with (i) all of the goodwill and the business symbolized by the Mark, and (ii) all causes of action, claims, and demands or other rights for, or arising from, any infringement, including past infringements, of the Mark. The Assignor shall not, at any time after the date hereof, claim any right, title or interest to the Mark.
2. Assignor further agrees, without further consideration, to perform such other lawful acts and execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner or proprietor of each of the rights hereby conveyed.
3. Subject to the terms hereof, Assignee hereby accepts such assignment of the Mark.




