### **Exhibit 3 – Trademark Assignment**

O&B authorizes the United States Patent and Trademark Office, and any other applicable government officer, to record DTN as the owner of the Trademarks, and as assignee of the entire right, title and interest in and to the same, and to issue any trademarks from the Trademarks to DTN. DTN shall have the right to record this assignment with all applicable government officers so as to perfect its ownership of the Trademarks. The right, title and interest is to be held and enjoyed by DTN and DTN’s successors and assigns as fully and exclusively as it would have been held and enjoyed by O&B had this assignment not been made.

O&B further agrees to: (a) cooperate with DTN in the prosecution of the Trademarks and foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including trademark applications, renewals, extensions and instruments of transfer.; and (c) perform such other acts as DTN lawfully may request to obtain or maintain the Trademarks and the trademarks (and any renewals or extensions) that may be granted thereto in any and all countries. DTN agrees to

reimburse O&B for any reasonable expenses incurred with complying with any requests made by DTN under this paragraph.
