## RELEASE OF SECURITY INTEREST IN TRADEMARKS

June 30, 2017

**WHEREAS**, TIMES HOLDING CO., a Florida corporation ("THC"), TIMES PUBLISHING COMPANY, a Florida corporation ("TPC"), TAMPA BAY NEWSPAPERS, INC., a Florida corporation ("TBNI"), TIMES MEDIA SERVICES, INC., a Florida corporation ("TMS"), and TREND MAGAZINES, INC., a Florida corporation ("Trend" and together with THC, TPC, TBNI, and TMS, the "Original Grantors") and CRYSTAL FINANCIAL, LLC, as agent (the "Agent") for itself and various financial institutions as lenders, entered into that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of December 6, 2013;

**WHEREAS**, TAMPA MEDIA GROUP, LLC, a Florida limited liability company ("TMG" and together with the Original Grantors, the "Grantors" and each individually a "Grantor"), the Original Grantors, and the Agent, for itself and various financial institutions as lenders, entered into that certain Amended and Restated Trademark Security Agreement (the "A&R Trademark Security Agreement"), dated as of May 2, 2016;

**WHEREAS**, the Grantors have repaid all of their obligations, and the Agent has accordingly agreed to release its security interest, under that certain Amended and Restated Term Loan Agreement, dated as of May 2, 2016, by and among THC, TPC, and TMG as borrowers, TBNI, TMS, and Trend as loan parties, the Agent, and the lenders from time to time party thereto;

**WHEREAS**, the Grantors have requested that the Agent execute this Release of Security Interest in Trademarks to evidence the Agent's release of the security interest that the Grantors granted in all of their Trademark Collateral pursuant to the Trademark Security Agreement and A&R Trademark Security Agreement;


**WHEREAS**, the Agent filed the Trademark Security Agreement with the United States Patent and Trademark Office (the "USPTO") on December 17, 2013, which was recorded at Trademark Reel/Frame: 5174/0924;

**WHEREAS**, the Agent filed the A&R Trademark Security Agreement with the USPTO on May 3, 2016, which was recorded at Trademark Reel/Frame: 5784/0148.

**NOW, THEREFORE**, the Agent hereby terminates and releases its security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement and the A&R Trademark Security Agreement) owned by Grantors, including, without limitation, those trademarks identified on Exhibit A attached hereto, effective as of the date set forth above.

This release may be executed in any number of separate counterparts, each of which shall, collectively and separately, constitute one agreement. The Agent acknowledges that this release may be filed with the USPTO to evidence the termination and release granted herein.
