The new name of the corporation is SUTRO SHOES, INC.

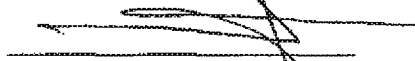
3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.
