## RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS (this "Release") is made as of August 31, 2017 by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Grantee") in favor of STANDARD FURNITURE MANUFACTURING COMPANY, LLC, as successor to STANDARD FURNITURE MANUFACTURING COMPANY, INC. ("Standard Furniture"), INTERNATIONAL FURNITURE MARKETING, LLC, as successor to INTERNATIONAL FURNITURE MARKETING, INC. ("International Furniture"), and INTERNATIONAL FURNITURE MARKETING ASIA, LLC, as successor to INTERNATIONAL FURNITURE MARKETING ASIA, INC. ("IFM Asia"; Standard Furniture, International Furniture and IFM Asia are referred to herein collectively as "Grantors").

WHEREAS, Grantors and Grantee are party to that certain Credit and Security Agreement, dated as of July 16, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"). All capitalized terms used in this Release which are not defined herein shall have the same meanings given such terms in the Credit Agreement;

WHEREAS, pursuant to the terms and conditions of the Credit Agreement, Grantee holds Security Interests in certain intellectual property rights owned by Grantors;

WHEREAS, pursuant to the terms and conditions of that certain Patent and Trademark Security Agreement, dated as of July 16, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), certain Grantors assigned, transferred and conveyed to Grantee, and granted to Grantee, Security Interests in all of such Grantors' rights, title and interests in and to the Patents (as defined in the IP Security Agreement) and Trademarks (as defined in the IP Security Agreement) (collectively, the "Intellectual Property Collateral");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on March 28, 2013 at Reel 030105, Frame 0344;

WHEREAS, pursuant to the terms and conditions of that certain payoff letter dated on or about the date hereof among Grantee and Grantors, Grantee has consented to the release of the Security Interests in the Intellectual Property Collateral (including, without limitation, the Patents listed on Schedule I hereto and the Trademarks listed on Schedule II hereto) (collectively, the "Released Intellectual Property Collateral"); and

WHEREAS, Grantee desires to release its Security Interests in the Released Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. The IP Security Agreement is hereby terminated and the Grantee's Security Interests in the Released Intellectual Property Collateral granted pursuant to each of the Credit Agreement and the IP Security Agreement are hereby terminated and released.

2. To the extent Grantee retains any interest in any Released Intellectual Property Collateral, Grantee hereby assigns, transfers and conveys to the applicable Grantor all of Grantee's rights, title and interests, now owned or hereafter acquired, that it may have whether by assignment or otherwise, in or to any continuing security interest or collateral assignment in the Intellectual Property Collateral and in or to any rights, title or interests in or to the Released Intellectual Property Collateral, including, without limitation, each of the Patents and the Trademarks and all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto and the goodwill of the business to which the Released Intellectual Property Collateral relates. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required by or through any Grantor in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors.

4. THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT MADE UNDER AND GOVERNED BY THE LAWS OF THE STATE OF GEORGIA, WITHOUT GIVING EFFECT TO THE PRINCIPLES OF CONFLICT OF LAWS THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION.
